

PUBLIC BUDGET HEARING MINUTES OF THE ELECTORS OF THE TOWN OF LINCOLN, KEWAUNEE COUNTY

7:00pm Wednesday, November 13, 2019, at the Lincoln Town Hall, N8497 County C, Casco, WI

1. The Public Budget Hearing was called to order at 7:03p.m. by Town Chairman, Cory Cochart. Pledge of Allegiance recited. Board of Supervisors (BoS) present: Jordan Nowak and Jesse Jerabek. Others present: Tim Strnad, Town Treasurer, Joe Jerabek, Town Assessor, Mick Sagrillo, Jodi Parins, Jenny Nowak, and Eric Weidner.
2. November 13, 2019 Agenda: Motion made to approve agenda as submitted (Parins/Sagrillo). Motion carried.
3. Public Comment: Sagrillo asked about Elna Farms contribution to road repair. Per Chairman Cochart, Elna Farms will pay \$5000/year for three years. Beginning in 2020 Budget, Revenue Category of R51 Reimbursement for Road Repair will include \$5000 through Budget 2022. Supervisor Jerabek suggested video-taping condition of ToL roads to get a baseline of current conditions. Discussion took place on Town of Lincoln tax payment and Kewaunee County maintenance expenses. Chairman Cochart questioned if there is a way to challenge share ToL may keep from taxes if County is not providing adequate maintenance; Treasurer Strnad did not currently have method. Supervisor Jerabek reviewed budgeted New Town Hall construction expense line item. Clerk will need to add additional revenue line item R46 for money collected for curbside pickup in 2019. Adjustments were discussed and made to preliminary 2020 Budget. Motion made to approve /adopt the 2019 total town levy to be paid in 2020 pursuant to Section 60.10(1)(a) of Wis. Statutes (Parins /Sagrillo). Motion carried (no Nay votes).
4. Motion made to approve the total 2020 highway expenditures pursuant to Sec. 82.03(3) of the Wisconsin Statutes (Joe Jerabek /Parins). Motion carried (no Nay votes).
5. Motion made to adjourn at 8:15pm (Sagrillo/Joe Jerabek). Motion carried.
