ToL Board of Supervisors Meeting Minutes Monday, April 6, 2020

I. The abbreviated regular meeting was called to order at 7:05p.m. by Town Chairman, Cory Cochart. Pledge of Allegiance recited. Board of Supervisors (BoS) present: Jordan Nowak & Jesse Jerabek. Others present: Tim Strnad, Town Treasurer, Joe Jerabek, and Mick Sagrillo. In light of the growing concern about COVID-19 ("coronavirus") in the State of Wisconsin and recommendations to cancel large, in-person gatherings for the next several weeks, the Town of Lincoln Board of Supervisors had moved to hold a shortened April 6th, 2020 meeting w/ abbreviated agenda in lieu of the regular length monthly April meeting. Town of Lincoln currently has no access to virtual or call-in conference type capabilities to cover meetings from the Town Hall. - VI. Disaster Declaration: Town of Lincoln COVID-19 Disaster Declaration signed by ToL Board.
- VII. DNR letter re: GLC: Sagrillo supplied letter of support of GLC, calling into question Kewaunee County's resolution not supporting GLC's acquisition of the 420 acres in the Black Ash Swamp; permission granted by Board to send letter.
- **VIII. Public Comment:** None were submitted to Town Clerk in writing. Discussion held on replacing Town Hall locks with panic hardware.
